This Privacy Policy was last updated and is effective as of March 28, 2019.

Thank you for visiting our website and for showing interest in our company. We are Kemper Water Control Systems, Inc. ("Kemper," "we," "us," or "our"). Your privacy is important to us, which is why we have developed this Privacy Policy to explain our practices regarding the use and disclosure of personally identifiable information we obtain online from users of this website located at <u>www.kemperwatercontrol.com</u> (the "Website") who reside in the United States. - (b) Consent Kemper may process your personal information where Kemper has obtained your consent to the processing.
- (c) Contractual Necessity Kemper may process your personal information where such processing is necessary in connection with any contract that Kemper has with you.
- (d) Legal Requirements Kemper may process your personal information where such processing is required by applicable law.

Disclosures to Third Parties

If you are a GDPR Data Subject, your personal information will not be disclosed to third parties except where it is necessary for fulfillment of Kemper's obligations to you or where Kemper is obliged or permitted to do so by law (including, without limitation, through the terms of any agreement Kemper may have with you), or where Kemper makes disclosures that are otherwise consistent with the uses described in this Policy.

Security of Personal Information of European Residents or Other GDPR Data Subjects

Kemper has policies and technical and organizational measures in place which are intended to safeguard and protect your personal information against unauthorized access, accidental loss, improper use and disclosure. However, you should be aware that information transmitted over the internet is not completely secure because of the nature of the internet and that systems and measures used to secure information are not flawless. Retention of Personal Information of European Residents or Other GDPR Data Subjects

- (a) Right of Access You have the right to be informed about what personal information Kemper holds about you and to a copy of this personal information.
- (b) Right to Rectification You have the right to have any inaccurate personal information which Kemper holds about you updated or corrected.
- (c) Right to Erasure In certain circumstances you may request that Kemper delete the personal information that Kemper holds about you.
- (d) Right to Complain You have the right to lodge a complaint regarding the processing of your personal information to an applicable governmental or supervisory authority in your country.
- (e) Right to Withdraw Consent Where processing of personal information is based on your consent, you have the right to withdraw such consent at any time.
- (f) Right to Object Where Kemper relies on our legitimate interests to process your personal information, you have the right to object to such use and Kemper is required to discontinue such processing unless Kemper can demonstrate an overriding legitimate interest in such processing.
- (g) Right to Restriction You have the right to request that Kemper stop using your personal information in certain circumstances including if you believe that the personal information Kemper holds about you is inaccurate or that Kemper's use of your personal information is unlawful. If you validly exercise this right, Kemper will store your personal information and will not carry out any other processing until the issue is resolved.
